

Ocean Grove Giant Spring Flea Market

Saturday, May 30, 2015

Rain or Shine

Sponsored by the Ocean Grove Area Chamber of Commerce, the flea market is held on Ocean Pathway from in front of the Great Auditorium over to Ocean Avenue. Spaces are approximately 10' x 10' and you will need to bring your own tables. The fee for each space is **\$115.00**. **If your space is not completely clear of debris by 6:00pm, you will not be invited back.** Dumpsters will be available **ONLY** for paper, flat boxes, etc., and there will **NOT** be any disposal of unwanted furniture or large items. If any questions arise, someone is stationed at Chamber Headquarters in front of the Albatross Hotel at 34 Ocean Pathway to help you.

Your **entry fee** is refundable **only** with **AT LEAST 15 days** advance notice of cancellation.

Sub-leasing of spaces is not permitted without prior written approval by the Chamber of Commerce.

Set-up time is 6:00am with the public arriving at 9:00am. **Market closing time is 4:00pm.** All spaces must be completely clean by 6:00pm. **(The Section containing #101-140 must vacate their spots by 4:30pm.)**


If you request to be in this section, you are agreeing to comply with stipulation.) You must leave by 6:00pm (4:30pm #101-140) or you will forfeit your right to participate in any future Ocean Grove Flea Markets. This will be strictly enforced.

Food Vendor's fee is \$300.00 PLUS A \$50 DEPOSIT (\$350.total). Deposit is refundable upon a positive clean-up inspection by the Chamber prior to departure. Those using cooking fuel must apply for an Ocean Grove Fire Prevention Permit. The Neptune Dept. of Health will perform an on-site inspection.

If you participated in Spring 2014, you will be given until March 15 to reserve the same approximate space. After this date, spaces will be assigned on a first come, first served basis until we are sold out.
