

**Ocean Grove Spring Fling
ARTS & CRAFTS FESTIVAL

RAIN OR SHINE**

Sponsored by the Ocean Grove Area Chamber of Commerce, the Spring Fling will be held on Main Avenue, from Central Avenue to New York Avenue, on Pilgrim Pathway and in Auditorium Square Park. Spaces are equal to one car space (10x10). You must bring your own table and tent. The cost is \$90 per space, \$75 for O.G. Chamber Members. The entry fee is refundable only with at least 15 days advance notice of cancellation. **This festival is open only to artists and crafters selling items that you yourself make – a web site or photos of your work must be submitted by first-time participants.** Set-up time is 8:00am with the public arriving after 10:00am. Closing time is 4:00pm. All spaces must be completely vacated by 6:00pm.

The food vendor fee is **\$115 PLUS an additional \$50 deposit** for clean-up, refundable upon positive inspection by Chamber of Commerce before departure. Vendors must include information on their offerings and those using cooking fuel must apply for an Ocean Grove Fire Prevention Permit. **Please detail your set up and needs on the reverse of this application.** An on-site health inspection will be conducted by the Monmouth County Health Dept.

Please respond by Wednesday, March 1st, 2017 to request your previous space (or one nearby). Spaces are not guaranteed. After this date spaces will be assigned on an as-available basis.
